COMMITTEE OF THE WHOLE MEETING  
JUNE 9, 2025**

Meeting was called to order at 5:00 pm by Mayor Raymond Radis. Pledge of Allegiance was recited followed by a moment of silent meditation.

Certification of Open Meeting Law: Agenda was posted June 6, 2025.

Roll Call: Sheila Pulice, Jody Kugler, Mark Wilton, Danielle Reysen, Christopher Foos. Absent: Jon McConnell. Also Present: City Attorney Jesse Spankowski, Police Sergeant Jessica Schroeder, Public Works Director Jason Carley.

Agenda: Motion made by Foos, second by Wilton to approve the agenda. Motion carried.

Appearance: Richard Gerstein addressed the Committee to give an update of the “Friends of the Mill Pond”.
